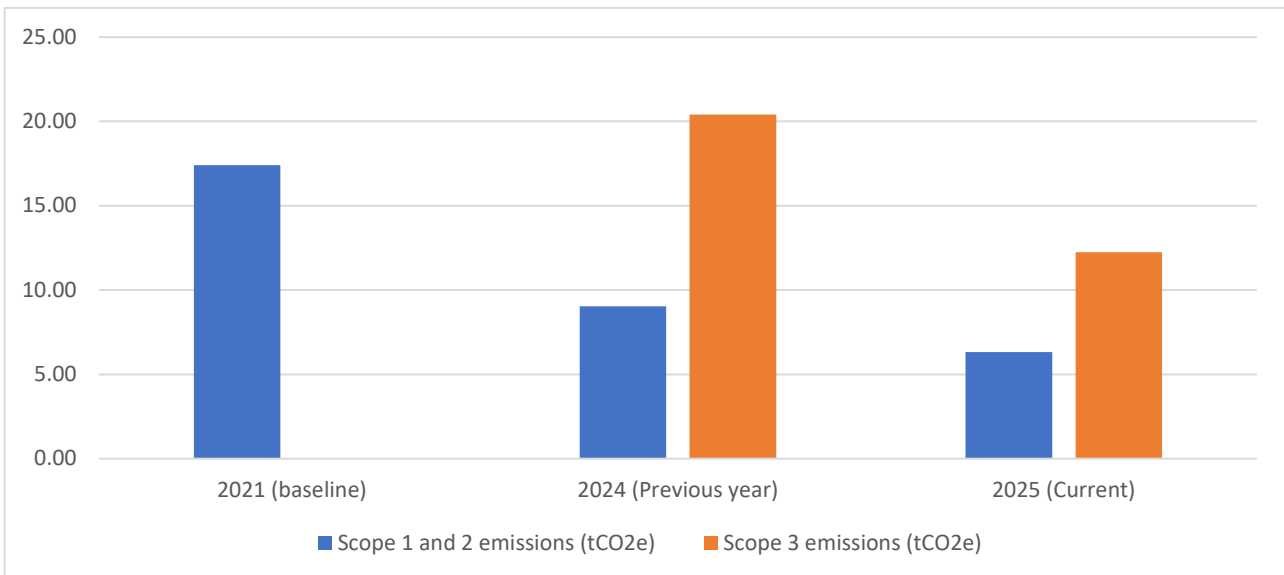

Emissions reduction targets

We have set the following targets to reduce our carbon footprint:

- 40% reduction in Scope 1 and 2 emissions by 2028 (from 2021 baseline)
- Year-on-year reduction in Scope 3 emissions through travel optimisation and remote working
- Net Zero across all scopes by 2050

Carbon Reduction Initiatives Completed

To achieve our carbon reduction targets, we have implemented and committed to the following measures:

Energy & Facilities

- Transition to LED lighting across office locations
- Use of energy-efficient IT equipment
- Reduced office footprint through hybrid working

Travel & Commuting

- Remote and hybrid working as standard
- Preference for virtual meetings over travel
- Encouragement of public transport use where travel is necessary

Procurement & Supply Chain

- Engagement with suppliers to understand and reduce their carbon impact
- Preference for suppliers with environmental and sustainability policies
- Reduced paper usage through digital systems

Workforce Practices

- Digital onboarding and compliance processes
- Reduced physical documentation
- Centralised systems reducing duplication and waste

Governance & Organisational Boundary

This Carbon Reduction Plan covers emissions from:

- Daytime Healthcare Recruitment Limited
- Quality Care Cover Limited, a wholly owned subsidiary

Emissions are reported on an operational control basis, covering activities over which the organisation has direct management control. Responsibility for carbon reduction sits with senior management, with oversight embedded into operational decision-making.
